

## **e-Procurement Vendor's Registration Fees Payment Scheme**

### **Introduction:**

The fees under this arrangement for vendors participation in various bidding processes on the PPCC's EGP platform is intended to ensure:

1. The sustainability of the electronic procurement system after external funding is discontinued;
2. That Vendors can afford access to the platform based on their financial and technical abilities;
3. That the PPCC becomes a more autonomous public procurement & concession regulator, and
4. Guarantee that registered vendors are serious in their commitment to be listed to participate on the electronic procurement platform.

### **EGP VR Registration Modalities:**

- a) That vendors registration is based on the estimated cost and threshold of the procurement packages being bided for
- b) That the lowest level estimated contract thresholds are exclusively left for SBA eligible vendors; nevertheless, if such contract cannot be adequately delivered by such category of vendors, the approval of such package for non-SBA eligible vendors should make it accessible to other vendors to deliver same;
- c) That bidders registered for higher contract thresholds may also qualify to participate in lower threshold processes except those exclusively meant for SBA eligible vendors and has not been approved access by the Commission base on their (SBA eligible) inability to deliver;
- d) That vendors registered for lower threshold contracts shall only participate in higher threshold processes upon the upgrading of their fee's payment to the desired upgraded contract thresholds they which to participate in, and
- e) That other packages above the minimum contract threshold may be assigned as SBA approved base on the identified abilities of Liberian owned vendors to delivered them; notwithstanding, such vendor must update to the required fee to participate in such category;
- f) That registration shall be done annually base on the fees reflected in the attached schedule on page number 2.
